

條款細則

1. 報名須以學校為單位，參加者必須為於香港註冊的全日制中小學校的在讀學生。
2. 主辦單位在有需要時會要求學校遞交有關證明文件的副本，以便核實其申請資格。
3. 每所學校最多可提交三張由不同學生於2025年至2026年內拍攝的相片。
4. **嚴禁提交**任何全部或部分由人工智能 (AI) 生成、合成或大幅修改的圖像。即使參加者對AI 輸出進行後期調整，若內容非由相機或手機親自拍攝，亦視為不符合資格。違者將被取消參加資格，已入選者將被撤銷資格及追回證書。
5. 相片作品內容須以於香港境內拍攝的自然生態物種為主題，並符合以下相片規格要求：
 - 長寬比例：16:9（橫式）
 - 解析度（像素）：1920×1080或以上
 - 檔案格式：JPG
 - 檔案大小：5MB 或以下
6. 照片不得包含圈養、束縛、受人為操縱的動物，亦不接受動物模型、動物標本、任何家畜或寵物。
7. 不得為了拍攝照片而做出任何傷害或驚擾動物或破壞其棲息地的行為。使用可能使主體感到痛苦、危險或失明的照明方式；以及近距離在巢穴或洞穴中使用鏡頭拍攝照片（允許使用長焦鏡頭）。
8. 任何涉及干擾、誘餌（包括用食物/餵食器、氣味、聲音引誘）或任何吸引手段的攝影作品均不符合參加資格。參加作品必須在自然環境中拍攝。
9. 參加者必須保證提交之相片為本人親自拍攝及擁有全部權利。嚴禁冒用他人作品、冒充他人身份提交，或提供虛假資料。一經發現，即取消資格，並可能通知就讀學校處理。
10. 參加者保證其作品不會侵犯任何第三者的版權或其他知識產權。若因提交作品導致主辦單位或任何第三方遭受索償，參加者須自行承擔全部法律責任及賠償。
11. 參加者同意，若作品入選，主辦單位有權在非商業用途下（包括但不限於展覽、宣傳、教育活動、網站及刊物），永久免費使用該作品的複製、展示、出版及傳播權利，而無需另行支付費用。參加者保留作品的原創版權，但不得因主辦單位的合理使用而提出異議。
12. 主辦單位擁有最終甄選及解釋權。所有決定為最終決定，不得異議。
13. 學校及參加學生提交作品即表示同意遵守本條款及細則的所有規定。
14. 主辦單位保留隨時修改條款的權利，並會於活動網頁公布最新版本。
15. 如有任何爭議，主辦單位的決定為最終及不可推翻。
16. 本活動受香港特別行政區法律管轄。
17. 透過本表格所提供的個人資料只作安排活動之用，並會存檔於本館作記錄。根據個人資料（私隱）條例第18及22條及附表1內第6項原則的規定，閣下有權要求查閱及改正本表格所載的個人資料。

Terms and Conditions

1. Registration must be submitted **on a school basis**. Participants must be current full-time students enrolled in primary or secondary schools registered in Hong Kong.
2. The organiser reserves the right to request schools to submit copies of supporting documents when necessary to verify eligibility.
3. Each school may submit **a maximum of three photographs**, each taken by a different student between **2025 and 2026**.
4. Any images that are wholly or partially generated, synthesised, or heavily modified by **artificial intelligence (AI)** **are strictly prohibited**. Even if participants make post-processing adjustments to AI output, any image not personally captured by a camera or mobile phone will be deemed ineligible. Violators will be disqualified. Those selected who are found in violation will have their eligibility revoked and certificates reclaimed.

5. Photograph entries must feature natural ecological species photographed **within Hong Kong** and must meet the following technical specifications:
 - Aspect ratio: 16:9 (landscape orientation)
 - Resolution: 1920 × 1080 pixels or higher
 - File format: JPG
 - File size: 5 MB or below
6. Photos must not include captive, restrained, or animals manipulated by humans, animal models, taxidermy specimens, livestock or pets.
7. Participants must not harm, disturb animals, or damage their habitats for the purpose of taking photographs. The use of lighting that may cause pain, danger, or blindness to the subject is prohibited, as is close-range photography inside nests or burrows (long telephoto lenses are permitted).
8. Any photographic works involving interference, baiting (including the use of food/feeders, scents, or sounds to attract animals), or any other attraction methods are ineligible. All entries must be captured in the natural environment.
9. Participants must guarantee that the submitted photographs were **personally taken by them and that they own all rights to the images**. Plagiarism, impersonation, or submission of false information is strictly prohibited. Any such violation will result in immediate disqualification and may be reported to the participant's school for further action.
10. Participants warrant that their works do not infringe any third party's copyright or other intellectual property rights. Should any claim arise against the organiser or any third party due to the submitted work, the participant shall bear full legal responsibility and compensation.
11. Participants agree that if their work is selected, the organiser has the right to use, reproduce, display, publish, and disseminate the work permanently and free of charge for non-commercial purposes (including but not limited to exhibitions, promotion, educational activities, websites, and publications) without additional payment. Participants retain the original copyright of their works but shall not object to the organiser's reasonable use.
12. The organiser reserves the final right of selection and interpretation. All decisions are final and not subject to appeal.
13. Submission of an entry constitutes full acceptance and agreement to abide by all terms and conditions of this Campaign.
14. The organiser reserves the right to amend these terms and conditions at any time. The latest version will be published on the event webpage.
15. In the event of any dispute, the organiser's decision shall be final and binding.
16. This activity is governed by the laws of the Hong Kong Special Administrative Region.
17. Personal data provided through this form will be used solely for the organisation and administration of the activity and will be kept on record by the venue. In accordance with Sections 18 and 22 of the Personal Data (Privacy) Ordinance and Principle 6 of Schedule 1, you have the right to request access to and correction of the personal data contained in this form.
